Subject: New procedure for proper implementation of scheme namely Post Metric Scholarship to the students belonging to Scheduled Castes.

Kindly refer to the subject cited above.

The Post Metric Scholarship to Scheduled Caste students scheme was launched by the Government of India and was being implemented hitherto by this department and the benefit was being disbursed through the Higher Education, Industrial Training & Vocational Education Department, Technical Education Department as well as District Welfare Officers of this department. But it had been experienced that this system had created some confusion and in some cases had resulted in delays at times. Accordingly, the whole matter was reviewed by the Government and the role/jurisdiction of each department has been now clearly defined so that no inconvenience is caused to students and more students are able to receive the benefit of the scheme in time. The maintenance of data and accounts shall also become easy and accurate under the new arrangement. **The departments which will be responsible for implementation of the scheme along with the category of institutions are given below:-**

(iii)	District Welfare Officers	<ul style="list-style-type: none"> • All Courses which are not covered by Technical Education, Industrial training and Vocational Education and Education Deptt. in private colleges • All Medical and Para Medical courses in Govt., Non Govt. aided, private colleges and Universities • All Degree/Diploma courses in private unaided colleges, Professional Courses of Universities including B.ed. • All professional courses degree/diploma in Govt. or aided or private colleges.

These departments shall invite applications, sanction and disburse scholarship on their own level. They will demand budget from this department as per the norms of Govt. of India's scheme in two installments. First installment shall be demanded in the month of April and second in the month of October every year.

Forms for Post Metric Scholarship Scheme can also be down loaded from the Departmental Website www.socialjusticehry.nic.in. It is requested that forms down- loaded from the website also be accepted. **Only for DWO's.**

All District Welfare Officers are hereby directed to accept the forms of students who apply through Department of Welfare of Scheduled Castes and Backward Classes specified at (iii) above. For other courses they may also guide the students properly to approach the Education/ Technical Education and Industrial Training & Vocational Education through their Head of institutions where they are studying.
