Subject:- Financial Assistance for training to Scheduled Caste candidates

in un-organized sector through privateinstitutions.

The Governor of Haryana is pleased to accord sanction for the formulation and implementation of the scheme namely:" Financial Assistance for training to Scheduled Caste candidates in un-organized sector through private institutions" from the year 2009-10. The details of the scheme are as under:-

Objective of Scheme

The objective of the Scheme is to ensure a steady flow of skilled workers in different trades for the industry; to raise the quality and quantity of industrial production by systematic training of workers; and to reduce unemployment among the educated youth by equipping them for suitable industrial employment and to provide training to Scheduled Caste candidates in order to make them gainfully employed through short-term courses of skill development in various areas.

Nature of courses

Under this Scheme various job oriented courses will be started for Scheduled Caste persons and such courses would be like Computer Skills, Food Processing,

Welding, Carpentry, Dress Making, Hair Styling & Beautician, Plastic Processing, automobile Repair, Electrician, Plumbing etc.

Duration of courses

These courses/training programmes will be of short-term duration.

Stipend

Rate of stipend to be given to the students shall be decided by the implementing department.

Implementing Agency

These courses will be run by Government Department / Universities / Educational Institutions, Government or private. Henceforth they will be called Implementing Agencies.

Conditions of Eligibility

- 1. Candidate should be a bonafide resident of Haryana.
- 2. The candidate should belong to Scheduled Caste category.
- 3. Family income from all sources should not exceed Rs. 2.50 lakhs per annum.
- 4. Candidate should possess all the requisite qualifications as prescribed under the Scheme.
- 5. The student should be selected based on merit.
- 6. Any other condition as stipulated under the Scheme or by the implementing department.

Mode of Application

The implementing department shall invite applications from time to time for different courses under this Scheme.

Approving Authority

The Welfare of Scheduled Castes & Backward Classes Department will invite proposal from implementing Agencies. A Committee headed by Director, Welfare of Scheduled Castes Backward Classes Department consisting of Joint Director/Deputy Director, Chief Accounts Officer will scrutinize the proposals and Committee headed by Secretary of the Department, Director, Welfare of Scheduled Castes ell Backward Classes Department and Director of the concerned departmentand Chief Accounts Officer will finalize the proposal and the final modus operandi.

Funding Pattern

Family income from all sources should not exceed Rs.2.50 lacs per annum. Budget will be placed at the disposal of the concerned Department/Institute by the Welfare of Scheduled Castes & Backward Classes Department. Funds will be given to the Implementing Agency, for purchase of equipments. raw material, salary of staff, stipend etc.

Certification

On the successful completion of the course, the candidate shall be awarded a certificate by the implementing Agency. This Certificate should be valid from recognized/the competent regulatory body at the State/National Level like State; Board of Technical Education, CII, DGE&T etc. The examination mechanism shall be institution based and monitored by State Board of Technical Education/ Council and other concerned.

Monitoring

The monitoring of the financial and physical performance of the scheme will be donethrough seeking detailed information from the Department implementing the Scheme. On the physical aspects the department implementing the scheme will berequired to furnish quarterly progress reports and on the financial side, details of actual expenditure incurred during the year.

Evaluation

Welfare of Scheduled Castes & Backward Classes Department will get the scheme evaluated by entrusting a research/evaluation study to reputed institutions/agencies, on the performance of the Scheme from time to time.

Sanctioning Authority:

The amount will be sanctioned by the Heads of (Implementing Govt. Department. As well as Welfare of SC & BC Deptt. Haryana.
