No. 817-SW(2)-2012--- The Governor of Haryana is pleased to constitute a District Level Vigilance and Monitoring Committee in all districts to review the implementation of the provisions of the Act, relief and rehabilitation facilities provided to the victims and other matters connected therewith, prosecution of cases under the Act, role of different officers/agencies responsible for implementing the provisions of the Act and various reports received by the District Administration, as under:-

Functions of the Committee:

The committee shall review the implementation of the provisions of the Act, relief and rehabilitation facilities provided to the victims and other matters connected therewith, prosecution of the cases under the Act, role of different officers/agencies responsible for implementing the provisions of the Act and various reports received by the District Administration.

Other

1. The Headquarter of the Committee will be the concerned District Headquarter.
2. The Committee will meet at least once in three months.
3. The terms of the non-official members will be for a maximum period of three years from the date of the notification. However, the State Government may nominate or withdraw a non-official member at any time.
4. TA/DA will be given to the non-official members (excluding MPs/MLAs) at the rate of Group 'B' officers of the State Government for attending the meeting along with actual Bus/Train fare.
