Subject: - Anusuchit Jati Chattra Ucch Shiksha Protsahan Yojna

The Governor of Haryana is pleased to accord sanction for the formulation and implementation of “**Anusuchit Jati Chattra Ucch Shiksha Protsahan Yojana**” and further incurring of expenditure of funds provided under the scheme during the year 2009-10. The details of the scheme are as under:-

Objective:-

The main objective of the scheme is to arrest the drop out of Scheduled Castes girl students and to encourage them for higher education after 10+2 class to Post Graduate Classes and also to bridge the gap of adverse female sex ratio.

B. Rates of scholarship per annum:-

Note: The students who avail scholarship under the Govt. of India's "Post Metric Scholarship scheme for Scheduled Castes students" or any other scheme will not be eligible to get benefit under this scheme.

Conditions of Eligibility:-

- i) The students should belong to Scheduled Caste and should be Bona Fide Resident of Haryana State.
- ii) The student should be studying in the private aided/unaided and Govt. Institutions/universities, which are not covered under the schemes of Higher Education and Technical Education Departments.
- iii) The students whose parents / guardians income is above Rs. 1.00 lac per annum less than 2.40 lacks per annum are eligible to get benefit under the scheme.
- iv) The students who are once awarded scholarship under this scheme and secure promotion to the next higher class will be renewed scholarship in the next class whole duration of the course.
- v) The students awarded scholarship under this scheme will not be entitled to get scholarship under any other scheme except meritorious scholarship / Incentive.
- vi) The scholarship is dependent of the satisfactory progress and conduct of the student. If a student is found to have obtained a scholarship by false statements his/her scholarship will be cancelled forthwith and the amount of scholarship paid will be recovered at the discretion of the State Govt. The student concerned will be blacklisted and debarred from scholarship under any scheme forever.
- vii) **The scheme shall commence w.e.f. 01-04-2009.**

D. Documents to be submitted by the candidate/Institution:-

I) By the candidate.

1. Complete application in the prescribed Performa shall be submitted to the head of the concerned institution before the last date notified by the Department. In case the student is unable to submit application within the stipulated period, in such cases the application submitted within one year after the last date with genuine reasons can be considered by the competent authority i.e. Director, Welfare of Scheduled Castes & Backward Classes Department, Haryana.
2. Attested copies of Scheduled Castes Certificate, Haryana Domicile Certificate, and Proof of promotion to the higher class and the original receipt of fees paid for admission in the course/class by the student.
3. In renewal cases Scheduled Castes and income certificate are not required to be submitted with the application.

II) By the Institution.

The Head of the concerned institution shall forward all the applications (in original) under the signature of competent authority with seal to the District Welfare Officer concerned District in which the institute is situated. The students who are studying out of Haryana, their applications should be forwarded to the District Welfare Officer of the district to which the student actually belongs. The applications should be forwarded along with proof of recognition/affiliation of the Institution from the Central/State Govt./University/Council etc. in respect of non Govt. institutions.

E. Procedure for implementation of scheme.

The applications will be invited from eligible Scheduled Caste students by giving wide publicity in the leading News papers and All India Radio/TV. The application in the prescribed Performa along with all necessary documents/certificates should be sent to the head of the institution concerned. After the completion of all formalities, the heads of the institutions will send these applications to the District Welfare Officer concerned who will examine/scrutinize the applications on the basis of documents furnished by the applicant/Head of institution. The District Welfare Officer will sanction and draw the amount and send to the institutions concerned for further payment to the students through bank draft or any other mode decided by the department from time to time.

F. Mode of Payment

The first installment of scholarship amount for the first quarter will be paid to the students at the time of admission and the remaining amount will be paid in each quarter in equal installments in advance. The scholarship amount will be deposited in the bank accounts of the students by the institution as per the above schedule.

So far as Govt. and Aided medical institutions is concerned, the reservation policy of the State Govt. is implemented and all the District Welfare Officers will collect information about the number of SC students along with demand of funds as per the provisions of the scheme from these institutions situated in their district in the month of April every year. But in the private/unaided institutions the reservation policy of the State Govt. is not applicable and the number of SC students cannot be readily available, hence the District Welfare Officers will contact all the private/unaided institutions situated in their districts and negotiate with them by explaining the scheme in the month of April and collect the above information. The District Welfare Officers will send the above consolidated information to the Headquarter by 15th May. The Director, Welfare of Scheduled Castes and Backward Classes Department will allocate the whole funds to the District Welfare Officers as per their demand by 30th May and they will send 1st installment of 50% funds in advance to the institutions concerned by 30th June/before the date of admission. The SC students studying in

the institutions out of HaryanaState will be sanctioned scholarship on the receipt of the applications. Second installment of 50% funds will be sent to the institutions in the month of October.

Head of Account

The expenditure under the scheme will be debatable to the head “2225- Welfare of Scheduled Castes/Scheduled Tribes and Other Backward Classes -01- Welfare of Scheduled Castes -277- Education-76-Anusuchit Jati Chhattra Shiksha Protsahan Yojna (Plan) 2009-10”.
